NOTICE OF PUBLIC HEARING

The Board of Directors of the **Hillsboro Fire Protection District of Jefferson County, Missouri**, will hold a **PUBLIC HEARING on Wednesday, September 9, 2020, at the hour of 7:00 P.M.** Central Daylight Time, at the **Boardroom, Fire House No. 1, 120 Fifth Street, City of Hillsboro, Missouri, 63050, on the proposed rates of levy of the district**, at which hearing citizens may be heard. The totals of assessed valuations for Jefferson County, Missouri, having been provided to the District at the date of this publication, by category, with some categories being incomplete, in order to advise the District of the valuations within the District and upon which the District shall predicate its levy rates; the total assessed valuations of said County may be changed by said County Assessor after this publication; the total assessed valuations for categories of taxable property within the District, as now known, for the years 2020 and 2021, are as follows:
